Ministry of Education Classroom Request

The Ministry of Education (MoE) has requested the use of six A Block classrooms for Term 4 for Gate Pā Primary School use while they are completing a reroofing project. The MoE believes our school is over-coded.

The Tumuaki noted that the school is not over-coded in all subject areas and raised concerns about where students will be placed for exams and Continuous Assessment Activities (CAAs) if the classrooms are released.

The MoE and Gate Pā Primary have offered to assist with logistics, and Gate Pā Primary will cover all associated costs, including lighting and heating. The Board is required to provide a response to the MoE regarding the number of classrooms that can be released for Term 4.
